**Guest Speaker, Laurel Anderson:** Gave a presentation called "The Power of Color" Some take aways from this are: learn the color wheel for pleasing color combinations, look how other artists use color in quilts, greeting cards, magazines, etc.; realize that seasons and your country of origin may influence your color preferences. Colors evoke emotions. Businesses pay close attention to color and Pantone selects a "color of the year". Laurel then presented a Trunk Show of her quilts, highlighting how she used color.
